

On Your Toes Dance Academy & Performing Arts, Inc.  
Enrollment & Recital Agreement

1. Payments accepted are cash, debit/credit card, or money orders. We do not accept checks. When paying at the school, you must obtain a receipt at all times, as this will be the only verification of payment for your records and ours.
2. Lower School refers to all students enrolled in Teeny Toes, Kinderdance, Intro to Dance and Combo classes. Upper school refers to the more serious older students.
3. All tuition, recital, rehearsal, costume and dancewear payments are non-refundable and must be prepaid. All tuition must be pre-paid prior to the student attending any classes – no exceptions.
4. While your child is enrolled at the school, you are responsible for the tuition each and every session whether your child attends classes or not (even in the Summer.) It is the parent's responsibility to bring their child to class consistently and in the school's assigned attire.
5. A student may only be un-enrolled prior to the beginning of a session and **only** via email. If we do not receive an email, you are still financially responsible for every monthly session while your child is enrolled.
6. Tuition is a yearly fee paid for in either ten or twelve installments regardless of Summer attendance. Tuition is due in June and July whether your child attends classes or not.
7. Past due accounts will be transferred to our collections company and be assessed a 40% additional recovery fee for collection expenses.
8. All students at OYT are required to participate in the school's yearly recital. A recital deposit in the amount of 50.00 is due at registration. This deposit is non-refundable and confirms your child's participation in the recital.
9. The recital cost starts at 225.00 depending on how many dances your child is in. Unlike most dance schools, our fee includes everything: your child's costume(s), 5 tickets to the show and the DVD shot by a professional company.
10. All communication to parents is dispersed through the app REMIND. Reminders about tuition payments and when the school is closed will be sent via these texts. **only. YOU MUST INFORM US IF YOU ARE NOT RECEIVING THESE MESSAGES.**

In case of emergency, On Your Toes Dance Academy is authorized to arrange for medical services for the student and I consent to appropriate medical and surgical service recommended by licensed medical professionals. I accept full responsibility for all costs of said medical care and any emergency treatments. On Your Toes Dance Academy will not be responsible for the cost of any medical care or emergency treatments. I hereby waive all claims whatsoever in connection with such medical treatments. I agree that On Your Toes Dance Academy will not be held liable for and agree to hold harmless from any and all liabilities, losses, damages, or expenses related to the student's participation in any activities at On Your Toes Dance Academy.
